

As we jump head first into 2020, I wanted to take a moment to share my complete gratitude for your support over the last year and give you a look at what's ahead. We have had a busy year and couldn't have done it without our donors, volunteers, supporters, and friends. You make our vision of creating a world where everyone has a decent place to live achievable!

In 2019, three new families were welcomed into homes built by our Habitat for Humanity volunteers and our community partners, spending over 4,745 nights under the roof of one of our Habitat Homes. Last year alone, our Habitat homeowners paid \$130,801 in mortgage payments and paid \$20,422 in property taxes. Our ReStore served more families than ever doing 10,473 transactions and bringing in over \$436,870 that will go directly toward the work we do in Walton County! On top of all this, we were named the Small Business of the Year in the north end of the county by the Walton Area Chamber of Commerce.

All of this was made possible by the generosity of our community. We look forward to a successful year ahead and hope to see you at our upcoming events and build days!
